W-2 eFile Pricing

Complete W-2 eFile Service: \$2.19/employee

W-2s are eFiled to the appropriate State and Federal agencies. Employee Copies are printed and mailed directly to your employees as well as posted to a secure web site for immediate access.

eW-2 (only): \$.99/employee

For employees who opt-in, using the eW-2 consent form, to only receive an electronic W-2 and do not want a paper copy mailed. Access letters can be printed or emailed to employees that contain instructions on how to retrieve their electronic W-2 from a secure web site.

Federal and State W-2 (both): \$.99/employee

Federal W-2 (only): \$.49/employee

Complete 1099 eFile Service: \$2.19/recipient

1099s are eFiled to the appropriate State and Federal agencies. Recipient Copies are printed and mailed directly to your employees as well as posted to a secure web site for immediate access.

e1099 (only): \$.99/recipient

For recipients who opt-in, using the e1099 consent form, to only receive an electronic 1099 and do not want a paper copy mailed. Access letters can be printed or emailed to employees that contain instructions on how to retrieve their electronic 1099 from a secure web site.
